



New Member Requirements

Applicants to Greater Nashville REALTORS® must complete two New Member Requirements within the first 90 days of membership:

- Complete the free **New Member Orientation** class, held in our classroom
- Complete a free **Code of Ethics** class, offered online or in our classroom

If an applicant fails to complete both orientation requirements and is not granted an extension, the application become void, forfeiting both the application and the application fee. The applicant must then reapply and pay another \$200 non-refundable application fee.
